BOROUGH OF CALIFON HUNTERDON COUNTY, NEW JERSEY ORDINANCE NO. 2022-05

AN ORDINANCE OF THE BOROUGH OF CALIFON, HUNTERDON COUNTY, STATE OF NEW JERSEY CREATING TITLE 5, BUSINESS LICENSES AND REGULATIONS, CHAPTER., BUSINESS INSURANCE REGISTRATION, OF THE BOROUGH CODE OF ORDINANCES

WHEREAS, Governor Murphy signed P. L. 2022, c.92 on August 5, 2022, which requires business owners and rental unit owners to maintain certain liability insurance policies and to register the compliant certificate of insurance with the municipality annually in which the business or rental units are located; and,

WHEREAS, the Borough of Califon establish a reasonable administrative fee for the certificate of registration required pursuant to the Act for properties located in the Borough; and

WHEREAS, the Borough of Califon Council declares that it is in the best interests of the Borough and its residents to establish a fee pursuant to the Act to cover administrative costs incurred in collecting and processing certificates of registration.

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Califon, Hunterdon County, New Jersey, as follows:

SECTION 1. Title 5, Business Licenses and Regulations, Chapter Business Insurance Registration, of the Borough Code of Ordinances is hereby created as follows:

CHAPTER-BUSINESS INSURANCE REGISTRATION

5- Business Insurance Registration Required.

It is unlawful for any owner of a business, owner of a rental unit or units, or the owner of a multifamily home of four or fewer units, one of which is owner occupied, to operate within the Borough without first registering its certificate of insurance demonstrating compliance with the requirements of N.J.S.A. 40A:10A-1, et seq., and paying the registration fee required herein.

5.— Entities Covered.

The following entities are required to register their certificate of insurance under this Chapter:

- A. Businesses, which for purposes of this Chapter shall mean, any person intending to sell or dispose of or to offer to sell or dispose of any goods, wares, merchandise or render any services for fees within the Borough. This shall include businesses operating on a temporary basis within the Borough such as peddlers, solicitors, and transient vendors and temporary retail food establishments and mobile food units.
- B. Owners of single rental dwelling units.
- C. Owners of multiple dwelling rental units.
- D. Owners of multi-family homes that include rental units, even where one unit is owner-occupied.

5.— Registration Official.

The Borough Clerk shall accept, approve, and file registration applications, and collect registration fees hereunder.

5.20.040 – Registration Fees, Expiration and Renewals.

All registration applications submitted under this Chapter, including renewals, shall be accompanied by a \$25.00 fee. Registrations shall expire on December 31 of each year. Renewals of existing registrations must be submitted no later than December 1 of each year.

5.— Application and Insurance Requirements.

An application for a business insurance registration shall be accompanied by the required fee and shall be made to the Borough Clerk upon forms provided by the Clerk. The application shall contain the following information:

- A. Name and address of the applicant. If the applicant is a corporation, the name and address of its registered agent;
- B. The address of the rental dwelling units or business as applicable. If the registration applies to a transient business or a mobile food unit, a general description of the time frame for operation and area where the business will be operated;

C. A description of the nature of the business and the goods, property or services to be sold

or supplied; and

D. A certificate of insurance reflecting the required amounts of insurance in compliance with

N.J.S.A. 40A:10A-1, et seq.

5.- Violations and Penalties.

Any person or entity that violates the terms of this Chapter shall pay the registration fee plus a fine

of not less than \$500.00 but no more than \$5,000.00, plus any court costs.

SECTION 2. All actions of the Borough taken prior to the date of adoption hereof contemplated

by this Ordinance are hereby ratified and approved.

SECTION 3. If any section, paragraph, subsection, clause or provision of this Ordinance shall be

declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of

this Ordinance as a whole or any remaining part thereof.

SECTION 4. All Ordinances or parts of Ordinances of the Borough of Californ heretofore adopted

that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to

the extent of such inconsistency.

SECTION 5. This Ordinance shall take effect immediately upon its final passage, approval and

publication as provided by law.
