B. ESCROW PAYMENT:

Escrow Payment shall be in addition to the Cash Deposit (A) and shall be in accordance with Califon Ordinance Chapter 12.08 — Excavations, Section 110 — Fees as adopted by the Borough of Califon in 1985: the sum of fifteen (15) percent (minimum seven hundred fifty dollars (\$750.00)) of the estimated cost of the work as estimated by the applicant's contractor or engineer and approved by the borough engineer.

The moneys so filed shall be used to pay the cost of engineering inspection, legal services, unrepaired damages, or other legitimate costs to the borough assignable directly to the project. Within two months after completion and final release of the permittee, which shall not be granted until expiration of the twenty-four (24) month maintenance period, all unexpended moneys shall be returned to the applicant, except for the additional amount of twenty-five dollars (\$25.00) which shall be retained by the borough in its final application fee. In extenuating circumstances, the borough council may waive the fee and only require payment for services.
