AN ORDINANCE AMENDING THE LAND DEVELOPMENT ORDINANCE OF THE BOROUGH OF CALIFON, HUNTERDON COUNTY, NEW JERSEY TO AMEND CHAPTER 16-24, SECTION 16-24.010 DEVELOPMENT APPLICATION FEES

WHEREAS, the Development Application Fee Schedule set forth at Section 16-24.010.A. of the Land Development Ordinance no longer reflects the actual costs of processing and reviewing development applications and is in need of updating; and

WHEREAS, it is in the public interest to ensure that the development application and escrow charges are both reasonable and sufficient to cover the costs of processing and reviewing development applications;

NOW, THEREFORE, BE IT RESOLVED:

<u>Section One</u>. Section 16.24.010.A. of the Land Development Ordinance shall be amended to delete the chart presented after the introductory paragraph of Section 16.24.010.A. and replace it with the following chart:
