# B. RESOLUTION – APPROVAL OF 2020 PROFESSIONAL SERVICES CONTRACT – BOROUGH PLANNER – JAMES KYLE, KYLE & MCMANUS ASSOCIATES

The following Resolution was introduced for adoption:

# RESOLUTION 2020-30

WHEREAS, the Borough of Califon has a need to acquire a municipal Planner as a non-fair and open contract pursuant to provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, the Chief financial Officer has determined and certified in writing that the value of the acquisition will exceed \$17,500; and

WHEREAS, the anticipated term of this contract is one year; and

WHEREAS, JAMES KYLE OF KYLE & MCMANUS ASSOCIATES has submitted a proposal, indicating they will provide Planner services for the anticipated fee of \$140.00 per hour and

WHEREAS, JAMES KYLE, P.P. OF KYLE & MCMANUS ASSOCIATES has completed and submitted a Business Entity Disclosure Certification which certified that JAMES KYLE, P.P. has not made any reportable contributions to a political or candidate committee in the Borough of Califon in the previous one year, and that the contract will prohibit JAMES KYLE, P.P. from making any reportable contributions through the term of the contract; and

WHEREAS, the required certificate for the availability of funds has been filed by the Chief Financial Officer providing that legally appropriated balances are available to cover the amount of the contract as required by N.J.A.C. 5:30-14.5 and that fees for the aforementioned Planner services shall be made available by appropriate inclusion in either an annual municipal budget which includes current, revenue sharing and utility provisions, by budget amendments for Federal program spending or by inclusion in an appropriate bond ordínance.

**NOW, THEREFORE, BE IT RESOLVED** that the Borough Council of the Borough of Califon authorizes the Mayor and Municipal Clerk of the Borough of Califon to enter into a contract with JAMES KYLE, P.P., OF KYLE & MCMANUS ASSOCIATES as described herein as Planner on and in behalf of the Borough of Califon for the year 2020; and

**BE IT FURTHER RESOLVED** That the Business Disclosure Entity Certification and Determination of Value be placed on file with this resolution; and

**BE IT FURTHER RESOLVED** that a notice of this action shall be printed once in a legally designated publication.

# **COMMITTEE REPORTS**

Councilman Medea reported that the Parks Committee met for their reorganization meeting and discussed some projects slated for 2020 now that the bridge is re-opened. All agreed that they would like to see the basketball court in the Park resurfaced and expanded for 4-square. The Committee would also like to see the pathway to the basketball court improved. Harrington did provide a cost estimated of \$11,500; does not include replacing the hoops which, if done, could bring the price up to \$15,000. Council gave their support to these projects. Councilman Medea

will order infield mix for the ballfields and the Committee will work with the Environmental Commission to replant trees down by the river.

Councilman Medea stated that he did reach out to Nathan Snyder and invited him to the next meeting. Councilman Medea asked about any new Pedestrian signs that could replace the badly damaged one up by the General Store. The Clerk reported that there is a new one in the bays, along with a new base for it, however they need to be bolted together.

Councilman Medea reported that he will be speaking to the Police Chief about Nixel alerts to incorporate into our system.

Councilman Medea will ask the Recreation Committee about plans to unplug the new Christmas Tree.

Councilman Haversang reported that the Recreation Committee will hold their Reorganization meeting tomorrow night, January 22<sup>nd</sup>.

Councilman Haversang reported that Amanda Altavilla has agreed to be the Chairperson of the Recreation Committee for one more year only.

Councilman Janus reported that the Planning Board will meet tomorrow night, 1/21, for their Reorganization meeting.

The School Steering Committee has been fairly silent the last few weeks and no dates for meetings have been scheduled.

Councilwoman Smith reported that the Board of Education will meet on January 29<sup>th</sup>. There are special meetings scheduled on January 23<sup>rd</sup> and 24<sup>th</sup>; and Councilwoman Smith questioned whether or not any action will be taken at these meetings.

Councilman Baggstrom read the Police and Municipal Court reports for December. Councilman Baggstrom read and highlighted the Police Chief's 2019 Year in Review document that he had submitted and which the Mayor and all members of Council had copies of.

Councilman Baggstrom reported that he, the Mayor and Clerk will meet with the DPW at 9:00 am on Wednesday, January 29<sup>th</sup> to discuss streets & roads; prior to the bid opening at 10:00 am for the Main St. Improvements project.

Councilman Collins reported that the Board of health met on January 8<sup>th</sup> to reorganize. The rabies Clinic held on January 11<sup>th</sup> went well.

Councilman Collins reported that the Environmental Commission met and reorganized on January 14<sup>th</sup> and discussed the one Salem Oak seedling that will be delivered to all municipalities in the spring by the DEP.

Councilman Collins reported that he will be meeting with the Mayor, Tom Mathews, H.C. Director of Engineering and Tom Boorady, Borough Engineer on Wednesday, January 29<sup>th</sup> to discuss the Weis Dam and next steps. He is also trying to get Brian Cowden to this meeting also. On February 6<sup>th</sup>, Councilman Collins will be meeting with High Bridge Mayor, Michelle Lee at the H.C. Sustainability Hub to discuss a possible collaboration between the High Bridge Environmental Commission and the Califon E.C.

# **MAYOR'S REPORT**

Mayor Daniel reported that he had a conversation with Margaret Nordstrom, Administrator for Chester Borough, about Highlands monies available to municipalities for alternative wastewater systems, if interested in pursuing. Mayor Daniel stated that the Borough did engage the DEP with some alternative systems back a few years ago, but the DEP at the time lost interest. Apparently, the DEP is now interested in looking anew at some of these alternative systems and there is money from the Highlands to pursue the options. Councilman Collins will investigate. Mayor Daniel and Councilman Medea asked that the issue of Recreation committee sponsored adult volleyball being played at the school be on the next Council meeting agenda to discuss. Councilman Medea asked that the issue of residency be discussed particularly since the Borough is insuring this event under the Borough insurance policy.

Mayor Daniel reported that there will be 3 meetings on the 29<sup>th</sup> of January; streets & roads at 9:00 am; bid opening for Main St. improvements at 10:00 am and Weis Dam at 10:30-11:00.
