#### **NEW BUSINESS:**

Septic Waiver Request – 1 Lime Rock Lane, Block 4.01, Lot 13. Jason Boorman addressed the Board with a brief history of himself, his residence and his renovation plans. Michael Roth, Engineer of Roth Engineering requested for two waivers: 1) the disposal bed will be located only 8 feet from the existing curtain drain, which does not meet the minimum separation distance of 20 feet when a soil replacement installation is proposed. The engineer has proposed a 10 mil PVC liner along the sides of the disposal bed nearest the curtain drain for added protection. 2) The proposed septic disposal bed is only 45.8 feet from the existing septic system on neighboring lot 15, which does not meet the minimum separation distance 50 feet.

D.Blair asked how far was it from the house – M.Roth answered 32' approximately. D.Blair also asked about a basement and water in it – J.Boorman answered yes to basement w/subpump but no water issues. D.Blair asked how far below grade is the curtain drain – M.Roth answered 5' down. T.Murin mentioned water table is very high right now – and the curtain drain is working now. J.Boorman stated curtain drain remains dry except during the recent heavy rains. Liner material was discussed.

Motion to grant both waivers by D.Blair and Seconded by T.Murin. All present members were in favor.
