K.Hoffman presented two waivers #1) The toe of slope will be only 5 feet from the property line, which does not meet the minimum 10 foot separation distance according to County policy. The engineer will inspect the grading and certify that the final grading has not impacted offsite conditions. 2) The proposed disposal bed will be 26 feet from the existing disposal system on neighboring lot 29, which does not meet the minimum setback distance of 50 feet. B.Thomas to send letter to Hunterdon Cty BOH approving the waivers, contingent on the correction of their letter stating 5’ feet instead of 3’.
