Mark Anderson, Borough attorney, advised that he prepared a new Solicitors Ordinance based upon the Ordinance provided to him by clerk Mastro. M. Anderson advised that he also prepared just the NO Knock portion of a solicitors Ordinance, which could be adopted by itself and would accompany Califon's existing Solicitors Ordinance.

# RESOLUTION OF THE BOROUGH OF CALIFON

# Hunterdon County, New Jersey No. 2023-73

WHEREAS, the Borough of Califon, County of Hunterdon and the Township of Washington, County of Morris, desire to enter into an Interlocal Services Agreement for the provision by the Township of Washington to provide infield grooming services to the Borough of Califon; and

**Municipalities** can enter into such agreements pursuant to the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1, et seq.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Califon, in the County of Hunterdon and State of New Jersey as follows:

- 1. That the Mayor and Municipal Clerk are hereby authorized to execute the Interlocal Services Agreement between the Borough of Califon, County of Hunterdon, and the Township of Washington, County of Morris, for services by the Department of Public Works of the Township of Washington to groom the infields at Califon Island Park for a term to commence April 1, 2024, and to terminate on October 31, 202; and April 1, 2025, through October 31, 2025.
- 2. A copy of this Agreement is on file in the office of the Municipal Clerk for inspection by the public.
- 3. A copy of this Agreement shall be filed, for informational purposes, with the Department of Community Affairs, Division of Local Government Services, pursuant to rules and regulations promulgated by the Division.
- 4. This resolution shall take effect immediately.
