At this time, Mayor Daniel moved to Public Comments on the Agenda.

#### PUBLIC COMMENTS

J.Ruggiero asked Chief Almer about the number of calls the report reflected. Chief said it is average. L.Janas asked about the stop sign in front of the post office, M.Medea advised it had been put back up. Chief Almer reported that a citizen had called about the Island Park, in reference to picnic tables/benches being moved around. J. Ruggiero advised that cameras will be going up. M.Medea reported graffiti on the bridge, he called DPW and they will remove it on Monday. Chief Almer advised that a report should be called into the Police for documentation purposes.

Correction was noted by E.Haversang that Weis is spelled with only one "s".

**DISCUSSION - WEIS MILL DAM** William.Kibler, of Raritan Headwaters, spoke from the perspective of RHA, their goal is removal of the Weis Mill Dam. There is a lot of sediment, damaging the habitat and creating a warm water bathtub affecting downstream. Colder water brings down bacteria levels, which is one of their goals. RHA would request that Califor take ownership of the property. Califon and RHA would then enter into a five-year management agreement, which would allow RHA to remove the dam. The reason for five years is that federal farm bill funding cannot go to government entities, county or municipalities it can go to private owners and private entities like RHA. The Feasibility study will be done by the end of this year. This project is really about stream restoration not about dam removal. Council needs to approach Hunterdon County to acquire this property. C.Smith asked if we acquire the property and RHA is unable to fulfill restoration is Califon in a vulnerable position. B.Hibler feels confident based on the history of other projects that this project will be successful. J.Ruggiero asked about funding, B.Hibler said support from Congressman and US Senator to bring more federal money to the state is favorable - if farm bill funding were to fall through there are other resources and agencies they could apply through.. Cost will be better to forecast once the feasibility study is done. Engineering will be done to ensure no flooding will occur downstream. The resolution tonight will enable the Council to approach Hunterdon County to acquire the property. A letter of support for this project from Califon is being requested. There is a deadline for this letter of December 1, 2023.

B.Kibbler also discussed that South Branch Raritan River Restoration Project will hold an information session on November 29<sup>th</sup> from 7:00-9:00 pm at Lower Valley Presbyterian Church.

With no further comments to be made from the public, Mayor Daniel moved to New Business.

# RESOLUTION SUPPORTING THE TRANSFER OF PROPERTY KNOWN AS THE "WEIS MILL PROPERTY" FROM THE COUNTY OF HUNTERDON TO THE BOROUGH OF CALIFON

**WHEREAS**, a certain property commonly known as the "Weis Mill Property" (the "Property") is owned by the County of Hunterdon ("County"); and

WHEREAS, the Borough Council of the Borough of Califon ("Council") has for some time sought a transfer of the Property to the Borough of Califon ("Califon") as an addition to its open space; and

WHEREAS, Califon's intention is that upon a transfer of the Property to Califon, Califon will enter into a five-year management agreement with Raritan Headwaters to facilitate the removal of the existing derelict dam; and

WHEREAS, the Council understands that the County is now willing to transfer the Property to Califon, "as-is", with the understanding that Califon will enter into a five-year management agreement with Raritan Headwaters to facilitate the removal of the existing derelict dam; and

**WHEREAS**, the Council is willing to accept a transfer of the Property to Califon "asis";

**NOW, THEREFORE, BE IT RESOLVED** by the Borough Council of the Borough of Califon that Council herby declares its intention to accept a transfer of the Property from the County "as-is", and thereafter enter into a five-year management agreement with Raritan Headwaters to facilitate the removal of the existing derelict dam; and

**BE IT FURTHER RESOLVED** that the Mayor, the Borough Clerk-Administrator, the Borough Attorney, and all other necessary and appropriate representatives of Califon are hereby directed to cooperate with the County to affect the transfer as soon as practicable.

Councilwoman Smith reported that she attended the Historical Society meeting on the 14<sup>th</sup>. Holiday plans were discussed. A presentation was given about the sign on the bridge and how it was verified to the movie it's A Wonderful Life. Califon Board of Ed meet on the 15<sup>th</sup> - enrollment is at 82. The High Impact tutoring grant was not received by Califon School, this grant was very selective.

Councilman Baggstrom advised that he had nothing to report.

Councilman Ruggiero reported that cameras will be put up.

Attorney Mark Anderson reported that he passed the Judge's opinion of the Deckhut case to Council. If an appeal is filed, he will inform the Council.
