

VOTING INFORMATION FOR CALIFON RESIDENTS

VOTE-BY-MAIL

Mail-in ballots have been mailed to all Califon residents who previously requested them. If you believe you should have received one but didn't, please call the County Clerk's office at 908-788-1214.

REQUESTING A VOTE-BY-MAIL BALLOT

If you have not yet applied for a mail-in ballot, but wish to vote by mail for this election, you have two options:

OPTION 1: To receive your ballot by mail from the County' Clerk's office, they must receive your application for a vote-by-mail ballot at least seven (7) days prior to the election.

OPTION 2: To receive your ballot in person, you may appear at the County Clerk's office, 71 Main Street, Flemington, NJ, up until 3:00 pm on Monday, November 3, 2025. Your application for a vote-by-mail ballot will be processed immediately and a ballot issued to you there. You may choose to vote at that time or take the ballot with you.

RETURNING A VOTE-BY-MAIL BALLOT

Make sure your certificate, containing your ballot, is placed inside the transport envelope addressed to the Hunterdon County Board of Elections.

You have three options to return your vote-by-mail ballot:

OPTION 1: Return your vote-by-mail ballot by mail. All vote-by-mail ballots returned in this manner must be postmarked no later than Election Day.

OPTION 2: Deposit your vote-by-mail ballot in any one of the twelve (12) secure drop boxes **in Hunterdon County**. The drop boxes will be available for ballot drop-off until 8:00 pm on Election night. **ALL BOXES are under 24/7 video surveillance**, and ballots are picked up daily by a member of the Hunterdon County Sheriff's Office and delivered directly to the Hunterdon County Board of Elections.

OPTION 3: Deliver your vote-by-mail ballot directly to the Hunterdon County Board of Elections Office, 112 Broad Street, Flemington, NJ 08822, no later than 8:00 pm on Election Day.
